1. Introduction

This guide will provide Trademark Agents with the guidelines on how to change the contract data of their accounts.

Trademark Agents can update contract information at any time. Editing contract information will not change the status of any trademark records but will revoke all the SMD files of verified trademark records with a valid POU.



2. Change contract data

You first have to sign in to the TMCH web user interface.

Go to "My Account":


